- c) General Data Protection Regulations (<u>GDPR</u>) will come into force at the end of May and will restrict the ability to cold call for fundraising. There will also be an impact on the way that records are maintained. Roger is attending some training and Nick Swannel from Chiseldon PCC is producing some information for Chiseldon that can be shared at a later date.
- d) The PCC is aware of and concerned about the potential for a negative balance in church funds this year. A discussion took place about fund raising opportunities linked to Harvest and Christmas.
  - <u>Action:</u> It was agreed that Marion would circulate a previous 'appeal booklet' and that Sue would update it and circulate for comments.
- e) Bird proofing is required for the Belfry. Marion is following various lines of enquiry and will update the PCC.
- f) No issues were raised relating to the proposed Grounds Maintenance Contract. It was felt that a general 'tidy up' was needed and it was also noted that a new flag was needed.

<u>Action:</u> Marion will contact Jack Nobbs to ensure he is happy to continue providing the service. She will also contact Graham Parsons who has mentioned that he has a flag that he'd be happy to donate. Richard will organise a general churchyard clear up with volunteers.

- g) The PCC has been offered the opportunity to fundraise at Barbury Races. Jenny will be the representative for St Andrew and Marion for Maizey.
- h) Jenni and Marion will prepare the posy's for Mothering Sunday on 11<sup>th</sup> March.

Nominations for Churchwarden should be received prior to the Annual Meeting in April. The accounts will be available 2 weeks prior.
