1) Minutes of last meeting and matters arising

LHFIG – Martin Cook is arranging for the verge to be cut back up to the bus stop.

Currently waiting for a response from Martin Cook regarding road width and excess soil removal in OSA.

Additional signage has been investigated but currently do not feel it would be of huge benefit. There is a commercial brushcutter available which alongside safety equipment would cost in the region of £300.

Action: JW to send details to Alan Brown. Council approval to spend up to £500 in total on this equipment. Agreed unanimously.

Padlock purchased for the container.

Footpath outside The Forge is now reinstated.

Flood Warden is continuing to follow up on the drainage issues to prevent flooding this winter. JH and JW met with ARK who have agreed to carry out a topographical survey regarding flooding at Wet Pits.

Action: JH to follow up with ARK

Initial patching of the potholes and road cleaning was completed

Action: JW to request a more complete repair of the road surface on the corner outside The Forge

Action: JW to raise issue of footpath height and condition outside The Forge, Crowlynch and Southview in OSA with WCC.

The minutes were approved.

- 2) Village Maintenance
 - a) Flood Plan Update

Jeff Mason has been working on flooding issues over the summer

b) Update on SID

The SID is now in place and working.

c) Defibrillators

The Rockley defibrillator is now installed at Rockley Manor Stable Block. Steve Heaven has agreed to check on the defibrillators and we will need a maintenance plan in place.

Action: JW to arrange for Rockley defib to be registered with emergency services.

d) Village appearance

AP is looking into the Best Kept Village competition. Each village may need to apply separately. AP will review the guidelines and advise further.

Guidelines exist to help villages to apply and understand the criteria for judging.

3) Roads and Footpaths

a) Traffic speed on A346

A parishioner has raised concerns about the speed of traffic on the A346. This is under continual review and the SID is now back in place which will hopefully reduce speed again. Volume of traffic has reduced over recent years.

Action: JW to contact the police about checking speed from Marlborough to Swindon on their next visit.

Og Dog Day takes place on Saturday afternoon on the field behind the churchyard in Ogbourne St Andrew.
